SUMMARY

The Offer Price has been determined at HK\$0.65 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.65 per Offer Share, the net proceeds from the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses is estimated to be approximately HK\$40.0 million (equivalent to approximately S\$7.1 million). The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Offer Price and Net Proceeds from the Share Offer” below.

A total of 8,792 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS or to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service have been received for a total of 184,696,000 Public Offer Shares, representing approximately 18.47 times of the total number of Public Offer Shares initially available under the Public Offer.

The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. Due to the very significantly over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer – The Public Offer – Reallocation” in the Prospectus have been applied. Based on the Offer Price of HK\$0.65 per Offer Share, the net proceeds from the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses is estimate to be approximately HK\$40.0 million (equivalent to approximately S\$7.1 million).

The Company intends to use the net proceeds as follows:

- approximately HK\$27.6 million (equivalent to approximately S\$4.9 million) or approximately 69.0% of the net proceeds will be used to develop and strengthen the Group's injection molding business by enhancing and diversifying the capability and services for microfluidics, liquid silicon rubber and sterile packaging;
